

Rare Disease CTN Spotlight

The Rare Disease Clinical Trial Network is an initiative designed to attract and support rare disease clinical trials to Ireland. The network was funded by the HRB in 2022 and is led by Professor Rachel Crowley and Prof Cormac McCarthy at University College Dublin and St Vincent's University Hospital. The Network Manager Brendan Molloy was appointed in October 2022 and alongside Professor Crowley and Prof McCarthy manages the day-to-day activities of the network.


A rare disease is defined as a disease or condition which affects fewer than 1 in 2000 people. It has been estimated that up to 300,000 adults and children in Ireland are affected by rare diseases, more than 6000 rare diseases have been documented to date. Rare disease clinical trials are complex by their nature, specialised trial designs are required because of the very low numbers of participants and limited knowledge of these rare and ultra rare conditions.



Rare Disease Clinical Trial Network Objectives:

- Facilitate and support the conduct of trials in rare diseases
- Involve patients in the design of rare disease clinical trials
- Educate early career researchers in the design of rare disease clinical trials
- Increase the opportunities for rare disease patients to access high-quality

Accomplishing these objectives will result in increased patient engagement, more trial opportunities for rare disease patients, increased opportunities for investigator-initiated trials, significant industry investment into Irish healthcare, enhanced knowledge of rare disease through patient focused research.



RARE DISEASE CLINICAL TRIAL METHODOLOGY – ONLINE TRAINING EVENT:

The objectives of the event are:

- Broaden the network of rare disease methodology researchers;
- Develop the skills of researchers through workshops using practical scenarios in rare disease research;
- Explore potential new collaborations in rare disease methodology research;
- Raise awareness of rare disease research methods.

Attendees have the opportunity to:

- Meet key leaders in rare diseases research;
- Engage in formal and informal networking and idea generation with other trainees and investigators;
- Discuss career development and strategic planning for academic success;
- Explore research collaborations.


The event will be held in July 2023.
